## **ELECTRICAL INSPECTOR POSITION OPENING IN NEW DISTRICT**

The North Dakota State Electrical Board has an opening for an electrical inspector. Minimum qualifications are: A high school graduate with electrical trade school degree preferred. A licensed Journeyman capable of being a Master. Successful Journeyman candidate must take and pass North Dakota Master examination within 90 days of employment. Have a firm knowledge of the National Electrical Code and the North Dakota Laws, Rules and Wiring Standards. Ability to be a problem solver with excellent interpersonal, written and oral skills. Ability to learn computer system, read and trace circuitry, schematics and blueprints. Must be a self-starter committed to time management, highly motivated, teamwork, high quality customer service and be able to multi-task projects. Flexible scheduling and overnight travel required. Must be able to lift 50 pounds, climb ladders and scaffolds and follow department's safety procedures. Must possess a valid driver's license. Must successfully complete standard background and criminal record check.

The inspector will be located in the Williston area (District 10) and cover McKenzie, Williams, Divide and the western portion of Burke and Mountrail counties. A State Fleet vehicle will be provided for work purposes.

Applicants must complete an Application for Employment State Form 10950 (available at web site <a href="http://www.nd.gov/hrms">http://www.nd.gov/hrms</a>, any N.D. Job Service, or at the North Dakota State Electrical Board by calling (701) 328-9522). Applicants must also submit with the Application a resume and cover letter explaining how their education, experience, and skills will qualify them for this position. Applicants who are residents of North Dakota and eligible to claim veteran's preference must include Form DD214. Claims for disabled veterans' preference must include a current statement of disabled status from the Veteran's Affairs Office. Completed Applications must be received by the N.D. Job Service, 1601 E. Century Avenue, Bismarck, ND 58503 by 5:00 pm on Friday, September 5, 2008.

# WIRING CERTIFICATES NEED TO FILLED OUT COMPLETELY AND PROPERLY

The North Dakota State Electrical Board has received wiring certificates that do not contain all of the information needed for an inspection. In some cases, the certificates are being returned to the contractor for more information, so this office can process the wiring certificates and inspect the wiring project. When filling out a wiring certificate, we would ask that all contractors give their best description of the work

being done as well as include phone numbers so the inspector can contact the owner or appropriate party to make arrangements for an inspection. If a certain time of the day is best for the inspector to contact the owner or appropriate party, please include that information as well. Your cooperation in this matter is greatly appreciated.

## CODE VIOLATIONS NEED TO BE COMPLETED TIMELY

The N.D. State Electrical Board is experiencing code violations not being addressed until close to or after the due date. In some instances, the individual has indicated that they didn't understand the correction report. Each correction report lists the name and phone number of the inspector who wrote the report. We encourage you to review those reports when you get them and call the local inspector if there are any questions. On occasion, when there is a need for additional time, please contact the local inspector for an extension. If it is past the due date, you need to contact our office to get more time. Your cooperation in this matter is greatly appreciated.

Our records show that there has been 177 apprentices registered since the effective date of February 1, 2008. Approximately 50 percent of those applications have indicated that they

have not started any related training to be eligible to take the Journeyman exam. Hopefully, these percentages will change by the end of the year. As we have stated in the past, new individuals getting into the electrical industry need to have good mentors from both Master and Journeyman electricians and office staff. Please take the time out of your day to be one of those mentors.

During apprenticeship registration renewals that will be completed by January 31, 2009, we hope to inform you that the percentage of apprentices not enrolled will be much less.

# MINIMUM REQUIREMENTS WHEN INSTALLING SERVICES TO STRUCTURES

When installing service panels, there are some other items to install in addition to the panel. Here are some examples:

- → When installing an electrical service for a moved-in house on a basement, it is the responsibility of the electrical contractor to install some additional items:
  - 1) A smoke detector shall be installed interconnected with the other smoke detectors in the house as per North Dakota Wiring Standards §24-02-01-16.1.
  - 2) Install a three-way switch for the stairway as per NEC 210.70(A)(2)(c) and illumination for the panel as per NEC 110.26(D).
  - 3) Install a GFCI receptacle to serve the unfinished basement in addition to those receptacles for specific equipment as per NEC 210.52(G)(1 and 2).

It is also important to look over the home and communicate with the homeowner for any other additional items that were not installed on the home because of the home being moved from one location to the other.

- → When installing an electrical service for a detached garage associated with a dwelling, the following items shall be installed in addition to the panel:
  - 1) At least one wall switch located at the egress door to control at least one light for the outside of the garage and one light for the inside of the garage as per NEC 210.70(A)(2)(a and b) shall be installed. The light installed inside the garage may also serve as the illumination for the panel that is required as per NEC 110.26(D).
  - 2) At least one GFCI receptacle in the garage as per NEC 210.52(G)(1 and 2) shall be installed.

Please keep these requirements in mind when a customer requests that you install a service panel to their moved-in home or detached garage.

### WESTERN SECTION IAEI TO HOLD MEETING

## POWER TO GARAGES & OUTBUILDINGS WITH GARAGE DOOR OPENERS

Article 210(8)(A)(5), Exception 1, "GFI protection is not required on receptacles not readily accessible" was eliminated in the 2008 NEC. Based on comments received at continuing education classes and this office, this matter was presented to the Board. It was the decision of the Board that a single receptacle shall be permitted in lieu of ground-fault circuit protectors for garage door openers. This exception is not allowed for any other GFI-protected receptacle in the garage.
