


License and Apprentice Applications Rise Again

The number of electrical license & apprentice registration applications is still on the rise in North Dakota. In just seven months 959 master/journeyman and 720 apprentice applications have been processed.

Not all applications receive licenses or registrations due to a variety of factors, including insufficient experience or failure to meet application requirements. However, in the last seven months, the NDSEB has issued a total of 1,318 master/journeyman licenses & apprentice registrations. This is an increase from the first seven months of 2012 when the numbers were at 1,211 and an even bigger jump from the first seven months of 2011 when numbers were at 871.

A little over 500 of this year's applications have been reciprocals. NDSEB currently reciprocates journeyman licenses with Alaska, Colorado, Idaho, Maine, Minnesota, Montana, Nebraska, New Hampshire, South Dakota, and Utah, and reciprocates master licenses with Minnesota & South Dakota.



The North Dakota State Electrical Board accepts experience in electrical construction obtained under the supervision of a contracting master licensed electrician, as long as the work is done in an area where the jurisdiction regulating the work has similar licensing and inspection rules as the State of North Dakota.

Applicants are all subject to case by case review.

Some states don't require verification of electrical experience to obtain a license and some states or projects don't require electrical inspections. Time worked on projects in these states does not qualify.

In order for an applicant's time to count, the licensing requirements need to be similar to those in North Dakota and inspections need to have been performed by a governmental authority, such as a State Electrical Inspector or City Inspector.

Administrative Rule Becomes Effective July 1, 2013

As you know, the NDSEB has been working on clarifying the role of a contracting master or class B electrician. Through the process of adding/deleting verbiage from the ND Wiring Standards, this is the wording that was approval by the ND Legislative Council at a hearing on June 6, 2013. The committee changed some wording and made this rule effective July 1, 2013. Here is the rule as it will be written in the state wiring standards:

Section 24-02-01-02(3):

Master and class B electricians. A master or class B electrician may exercise that person's privileges as a licensed master or class B electrician for no more than one shop or business, and shall comply with provisions as required for contracting with the secretary of state's office as stated in North Dakota Century Code chapter 43-07. A master or class B electrician must be actively engaged in the supervision of every project certified under that electrician's license. A master or class B electrician shall notify the state electrical board office immediately upon changing from contracting status to noncontracting status for the shop or business they represent.

Doug will be assigned a new District #13 in eastern ND and Jerry will be the inspector for District 14, which at this point is still a roaming inspector position with the boundaries to be defined at a later date. Highlights from June Inspectors' Meeting

On June 27th, State and City Inspectors gathered in Bismarck for their bi-monthly meeting. The room contained all the usual suspects as well as a few new inspectors recently added to the team. Inspectors prepared for some rousing conversation on hot topics.

It is important to provide clear and consistent information statewide. The following were among the list of discussed topics worthy of noting in this issue of Connections:

Available Fault Current: NEC110.24 requires the maximum available fault current to be calculated and field marked on all service equipment. This marking shall include date calculation was done and be of sufficient durability for the environment. Exceptions include "Dwelling Units" and "Industrial Installations" - see definition at NEC 240.2. For an easy to use formula, go to MikeHolt.com, click on "Free Stuff", then "Short Circuit

Calculation", then "Fault Current Calculator.

 Portable Housing: We are seeing many versions of modular housing enter the State. If these products are to by-pass the State Inspection process, they must have a label from a third party inspection firm. This label tells us that they have met the wiring standards of North Dakota. Structures not bearing any third party inspection label will be subject to inspections and compliance of all applicable State and National Electrical Codes. Some of these products would require modifications



to be in compliance.

Dormitory Definition: The 2009 International Building Code states a dormitory is a space in a building where group sleeping accommodations are provided in one room or a series of closely associated rooms, for persons not members of the same family group,
