I agree to the following:

1. I hereby make and sign this application for the faithful performance of all electrical work assumed by me in strict compliance with all provisions of Chapter 43-09, North Dakota Century Code, and the requirements of the North Dakota State Electrical Board (Board).
2. I understand that the Board licenses individuals and not businesses, and that wiring certificates are legal documents issued under my license number, so any questions or concerns will be addressed directly to me as the contracting electrician.
3. According to N.D.C.C. §43-09-20: I will provide to the Board evidence of the existence of public liability insurance with a licensed insurance carrier, with policy limits (each occurrence) of at least five hundred thousand dollars for a master electrician and two hundred fifty thousand for a class B electrician.
4. I will be actively engaged in the supervision of every project certified under my electrician's license pursuant to N.D. Laws, Rules & Wiring Standards §24.1-03-01-06(5).
5. I will verify that all individuals working under my supervision doing electrical work in North Dakota maintains a current registration or license.
6. I understand that as a contracting electrician, I shall notify the North Dakota State Electrical Board immediately upon either changing from contracting status to non-contracting status or prior to leaving a firm to which I filed an application for the firm I represent pursuant to N.D. Laws, Rules & Wiring Standards §24.1-03-01-06(5).
7. I understand that if I fail or refuse to comply or demonstrate compliance at the request of the Board or its representative shall subject my license to non-renewal, suspension, or revocation by the Board pursuant to N.D.C.C. §43-09-15.
 - a. This could include, but not be limited to, reciprocating any of these conditions to any state in which I may be licensed.
 - b. Notifying the consumer of abandoned code violations that their property is not up to code and that they would have to hire a North Dakota Master electrician to correct these code violations, which could entail recourse against me by the consumer, and the owner of the firm in which I am representing.
8. I understand that if I fail or refuse to comply or demonstrate compliance at the request of the Board or its representatives, I may also be subject to a criminal penalty of construction fraud under N.D.C.C. §43-07-02.
9. I understand and accept the contents of the N.D. Laws, Rules & Wiring Standards, and will abide by them.

1. Pursuant to N.D.C.C. §43-09-09.2(2): Advertising prohibited - Exceptions – Liability - Penalty: Except as provided in this section, if an electrical license is required under section 43-09-09 or by local ordinance, a person may not advertise to contract for electrical services without being licensed as or being associated with a class B or master electrician unless that person intends to contract the electrical services with a licensed electrical contractor.
 - a. If a person associates with a class B or master electrician under subsection 1 and that association ends, that person is jointly and severally liable for any electrical services contracts entered under that subsection (which includes work performance and corrections).
2. I understand that if the Master or Class B electrician fails or refuses to comply or demonstrate compliance at the request of the Board or its representative, their license shall be subject to non-renewal, suspension, or revocation by the Board pursuant to N.D.C.C. §43-09-15.
 - a. This could include, but not be limited to, reciprocating any of these conditions to any state in which they may be licensed.
 - b. Notifying the consumer of abandoned code violations that their property is not up to code and that they would have to hire a North Dakota Master electrician to correct these code violations, which could entail recourse against not only the electrician, but also the owner of the firm.
3. I understand and accept the contents of the N.D. Laws, Rules & Wiring Standards, and will abide by them.
4. I understand that if I fail or refuse to comply or demonstrate compliance at the request of the Board or its representatives, I may also be subject to a criminal penalty of construction fraud under N.D.C.C. §43-07-02.
