APPLICATION INSTRUCTIONS

- All fields must be completed, including signature and date. Allow 1 to 2 weeks for processing.
- Submit application and the \$10.00 fee by one of the following:
 - Print, complete and mail to ND State Electrical Board, PO Box 7335, Bismarck, ND 58507 with a check or money order payable to ND State Electrical Board (NDSEB); or
 - Complete, download and email as a single PDF file to electric@nd.gov. Once an email confirmation is received from our office, applicant may call 701-328-9522 to make fee payment by credit or debit card.

APPRENTICESHIP INFORMATION

- Registration with the NDSEB is required within the first six (6) months of employment per ND Century Code 43-09-13.1.
- Apprentice registrations expire each year on January 31. Any hours worked while unregistered/not renewed will be lost and will not count toward obtaining your Journeyman license.
- Per ND Century Code 43-09-11 and 24.1-03-01-07, any person registering as an apprentice electrician after **January 31, 2008, is required** to complete one of the following to obtain a Journeyman license:
 - Successfully completed two years of electrical school approved by the board; or
 - Successfully completed five hundred seventy-six hours of training classes approved by the board; or
 - Successfully completed a professional electrician apprentice program recognized by the board.
